More than 3,000 positions were offered to job seekers from Mattayom 3 to Bachelor's Degree. The aim of this fair was to supply human resources to Hemaraj's customers in 6 industrial estates in Rayong,

PTT Asahi Chemical Co., Ltd. (PTTAC) has purchased 120 rai of land in Hemaraj Eastern Industrial Estate (Map Ta Phut) for construction of petrochemical plants producing Acrylonitrile (AN), Methyl Methacrylate (MMA) and Polymethyl Methacrylate (PMMA). The operation is planned to commercially run in 2010. Chonburi and Saraburi. With a great success, more than 6,000 new vocational graduates and job seekers visited the fair.

Vocational Education Commission (VEC) is one of the five main sections in Ministry of Education. Its role is to provide graduates of excellent vocational skills for industries. At present, there are approximately 1,000,000 students under direct operations of VEC: 700,000 students in Por Vor Chor and Por Vor Sor certificate curriculums and 300,000 from short vocational courses for general public. Currently, there are 404 nationwide vocational colleges under VEC's direct supervision, 20 of which located in Eastern Seaboard.

The Fair turned out to be a big success and we have slotted this in our planning again for the end of 2007.

At the job fair, we also organized an information exchange forum between vocational institute top executives and factories. We are trying to bridge a better understanding on the industrial needs and expectations of a skilled workforce. Based on the exchanged information, VEC will adapt their planning and adjust concentrations and curriculums accordingly. This is cooperation for governmental and private sectors. I would like to give credits and extend my appreciation to the commitment of VEC.

ESIE - Hemaraj ESIE's New Road Connection Opens Up More Than Just Business Prospects

Starting from April 2007, traffic congestion during rush hours on highway 331 in front of Eastern Seaboard Industrial Estate (ESIE) will be eased with the opening of Hemaraj's new highway traffic corridor at the northern end of ESIE. This will also provide a linkage to Hemaraj Eastern Seaboard Industrial Estate (Hemaraj ESIE).

As part of the development of Hemaraj ESIE, Hemaraj's latest industrial estate, the 3km traffic corridor is comprised of a 4-lane, 22.5-meter wide road that can be expanded to 6 lanes in the future. One of the beneficial features of the new road is its ability to ease outbound traffic with direct access to Laem Chabang Deep Seaport via Highway 3138 and to the new Highway 331.

Apart from the above, in the next phase VEC will try to realize "Dual Vocational Training" in our industrial estates. This means technical and vocational students (Por Vor Chor and Por Vor Sor) will come to factories for training of 3-12 months or more for first hand experience in the factories. They could convert hours trained as their study credits. In turn, factories will have access to skilled labor and will be able to identify students for future recruitment. This is a paid training with daily wages and small expenses on accommodation. We are sending out inquiries to all factories to see if the interest is there. If so, the implementation can be made by VEC.

Industrial Technology Assistance Program, Coming up Next

Even the biggest companies would need collaboration on technology adaptation when in foreign countries. Hemaraj has introduced the Industrial Technology Assistance Program (iTAP) of National Science and Technology Development Agency to offer a wide range of know how to optimize productivity, reduce waste, adapt levels of automation and tooling to fit with production quantities. iTAP houses a great number of knowledgeable scientists and researchers, and have close liaisons with large R&D institutes all over the world. More information on iTAP services can be found in this newsletter. And I hope you would explore a chance to benefit from it.

Highlights

Some 2,000 rai of Hemaraj ESIE is now available for sale. Of that, 765 rai of land has been designated as a Customs Free Zone. Small and Medium Enterprises looking to set up businesses on the new site will be pleased to know that detached SME Factory sized from 3,100-4,000 square meters will be available for rent and sale in June 2007.

"This is an addition we have eagerly been planning," said Mr. David Nardone, President and CEO of Hemaraj Land And Development Plc. "Not only does the new road significantly ease traffic snarls by creating a new access through the Hemaraj Eastern Seaboard Industrial Estate, but it also opens up more prime industrial land for investors. This new development is closer, only 27km to Laem Chabang Deep Seaport, and is open for business now."

Considerable infrastructure has already been put into place along the First Phase of Hemaraj ESIE. Electrical lines offering 22kv of power are in place. Underground civil work for phone lines offering ISDN local services, ISP and data communication leased lines by TT&T is completed in April.

"Civil engineers have constructed the water treatment plant in March with a capacity of 500 cubic meters per hour," said Mr. Tanin Subboonrueng, Industrial Development Director. He went on to say that a wastewater treatment plant will come on line in June with the ability to treat 3,000 cubic meters per day. When needed, this will be expanded to handle 6,000 cubic meters per day or more.

Hemaraj ESIE's main road will be able to accommodate thru traffic and offers initially 2 lanes then 4 lanes expandable to 6 lanes of reinforced concrete that is 52 meters wide. A full lighting system is up and operational in April 2007 "With this continued expansion, we are looking forward to accommodating more investors with the road and connection from Hemaraj ESIE to ESIE. Our current customers at ESIE will appreciate the additional traffic route to Laem Chabang Deep Sea Port. Hemaraj ESIE continues the opportunity to expand the manufacturing supply chain by doubling our ESIE land area of 8,700 rai by another 8,200 rai at Hemaraj ESIE," said Mr. Nardone.

Government Update

BOI affirms that the BOI investment promotion scheme will not be affected by the proposed changes to the Foreign Business Act.

Mr. Satit Chanjavanakul, Secretary General of the Board of Investment (BOI), said that the approval of the Cabinet on the amendment to the Foreign Business Act does not interrupt the Board's investment promotion policies and procedures. According to the Investment Promotion Act, the BOI allows foreign equity participation up to 100 percent in all activities eligible for investment promotion, except those specified in list 1 whereby BOI has already required Thai majority ownership, and in activities that fall under specific laws such as telecommunications, and marine, air and land transport.

Proposed Changes to Foreign Business

Act Don't Affect BOI Scheme

Therefore, companies that have already received or seek BOI investment promotion will not be subject to the proposed ownership rule revision, except those in the activities mentioned above. Currently, there are 7 categories covering over 273 activities in both manufacturing and services eligible for BOI promotion.

Hanil Forging Signs Hemaraj's First Partnership Deal of 2007

Hanil Forging, Korea's biggest and most wellknown forging company, has the honor of being the first company in 2007 to sign a new deal with Hemaraj Land And Development. Hanil Forging (Thailand) Co.,Ltd has purchased 18 rai of land at Hemaraj's Eastern Seaboard Industrial Estate (Rayong) to build factories that will produce axle shafts and spindles.

Hanil Forging (Thailand) Co. will also export some 70 percent of its production overseas.

Hanil Forging is Hemaraj's 114th automotive customer, and is proof that Thailand is well on its way of making the Eastern Seaboard the Detroit of the East.

Kiriu (Thailand) Casting Factory Starts Operations End of 2006



of *lkki Seisan* (production at a breath)," he said. "What this means is that once you start a job you shouldn't stop, but finish it in a breath in the same way a youngster gulps down a drink. This enables operations to go ahead with high productivity."

"This concept of 'production at a breath' is applied to each process of setting up our company, be it factory layout and construction or start-up operations."

Kiriu (Thailand) presents the sixth foreign production base for Kiriu Corporation. Regarding their decision of selecting ESIE as the location, Mr. Tohata said: "The Thai government's policy of fostering the automotive industry was the major force behind our decision. In addition to manufacturing cars, suppliers are also offered support from the government. The ESIE is very appealing because its core industry is automobiles, and there are also BOI privileges and well-maintained utility services such as electricity."

Kiriu (Thailand)'s main products are automobile brake disks and drums. The machining factory has already started its operations with a projected production capacity of 2,500 tons per month for casting, and 250,000 pieces per month for machined disk brakes.

"Currently in Thailand, 30 to 40 percent of casting parts for automobiles depends on imports," said Mr. Tohata. "Therefore, there is much significance to produce those parts locally. The 'integrated production' from raw material to products is an important goal for our company. We aim to become one of the best manufacturers of high-quality products in Thailand."

Hanil is regarded as one of the most efficient companies in Korea, and for this reason has received many awards. In the 1980s, Hanil received a Bronze Statue for Technology Development. In the 1990s, Hanil obtained ISO 9001 and QS 9000 Quality Certification and received an award as one of the 100 Excellent Korean Technologies of the 20th Century for its Unmanned Automated Manufacturing System. In 2002, Hanil obtained ISO 14001 Quality Certification for the manufacturing of aircraft parts.

In Korea, Hanil is the leading manufacturer of axle shafts and spindles for commercial. The company also has a long-term supply agreement for spindles with DANA Corporation, an American automotive company with a factory in Hemaraj's Eastern Seaboard Industrial Estate (Rayong). Hanil also manufactures bodies for high-tech guided missiles and precision parts for aircraft with the most advanced automated facilities.

"Establishing a factory in Thailand was an easy decision," said Mr. Sang-Kyu Lee, CEO of Hanil Forging. "The country's strong economy and welcoming manufacturing environment has given us the confidence to invest here. Thailand provides a safe and open environment, even for 100% foreign-owned manufacturers, to participate in one of the region's most dynamic automotive growth markets."

"The ESIE location has ideal land, industrial estate operations and utility conditions in an integrated automotive environment for Hanil's specialized forging needs. Our choice of ESIE allows us to supply our main automotive customer with ease."

Eyes Parts Export Expansions

Kiriu Corporation, an integrated manufacturer of automobile brake disks and drums (casting and machining), celebrated its 100th Anniversary last December.

While Kiriu finds its headquarters in Ashikaga city, Japan, the company in February 2006 established Kiriu (Thailand) at the Eastern Seaboard Industrial Estate (Rayong) (ESIE) with a registered capital of 250 million Baht. Kiriu Corporation holds the majority share of 95%, while the remaining 5% is held by Sumitomo Corporation Thailand.

Machining of parts began in November 2006, and construction work on the casting factory is rapidly proceeding in order to make it fully operational as soon as possible. Mr. Tohru Tohata, the President of Kiriu (Thailand) Co., Ltd., explained the reason why their factory became operational in such a short period of time after setting up the company.

"Mr. Toshio Nakagawa, the President of our

The company intends not only to supply their products to the domestic market, but also to start exporting them in the future. For this purpose, it is important to become competitive in terms of quality as well as cost, explained Mr. Tohata.

"By sending Thai managers, engineers and other staff to Japan for training, we think that it is possible to maintain the same level of product quality as in Japan. Our Japanese staff are learning Thai and our Thai staff are learning Japanese to ensure better and active communication. In the future we will gain more competitiveness in the international market by expanding operations further using our Thai staff," explained Mr. Tohata, confidently.

He also stated: "We are trying to make our factory a 'beautiful factory' by planting green trees and colorful flowers so that it will become attractive both for the factory workers and for people from the outside."

There seems to be a lot more to expect from Kiriu (Thailand) and its future activities.

Max (Thailand)



Fully Operating for Over a Year in Hemaraj's Detached SME Factory with Plus Structure

The Japanese company "Max" is widely known in Thailand. And this is best demonstrated by the fact that a stapler is called "Max" in Thai.

However, their product range is not limited to office and stationery supplies such as staplers. The company's Thai affiliate, Max (Thailand), was set up in August 2005 with a registered capital of 275 million Baht in the Free Zone inside of Eastern Seaboard Industrial Estate (ESIE). It is the third overseas production base for Max outside Japan.

After completing company registration procedures on August 25, 2005, Max (Thailand) swiftly moved into the factory building in ESIE on November 15. After the New Year's holiday in early 2006, they started knockdown production. The speed of their actions drew attention.

"We studied nine industrial estates as a possible location for our factory, and then selected ESIE. Once we made our decision, our actions were very quick," said Mr. Mitsuteru Kurosawa, the Managing Director of the company, emphasizing that their choice was the result of thorough research.

"At first, our preferences were on an industrial estate located in Ayutthaya Province in Thailand's central region because of easy sourcing, or an industrial estate in the west part of Chonburi Province, which was within commuting distance of Bangkok." items such as pillars and beams. Their projected annual production quantity totals approximately 20,000 pieces this year, and they plan to increase the quantity five fold to 100,000 pieces by 2008.

"We ship almost 50 percent of our nailers for packing related items to the US market, and 40 percent to Europe. All of our roofing and framing nailers are sold in the United States," said Mr. Kurosawa. "In the American construction market, we have seen our sales decline slightly, but the demand remains strong, so we forecast that the demand for our products will be expanding for the next three to four years."

Users in the US construction industry consider Max nailers to be robust and of high quality.

Commenting on the start of production in Thailand, Mr. Kurosawa said: "It has a significant effect on lowering production costs. It is my task here in Thailand to increase the local content ratio to give flexibility to the production cost. Our product is different from products of other industries in the sense that we cannot expect a high sales growth over a short period of time, but, once people use our products, we are confident that they will recognize the quality. By winning deep trust from users, the market share of our products will grow slowly but steadily."

Max (Thailand) expects their sales this year to be approximately 71 million baht, and plans to increase that amount to approximately 90.5 million baht in 2008. As the company anticipates production expansion, they have chosen Hemaraj's SME Detached Factory with Plus structure. This means that the company has spare land by the factory's side. Their expansion was already calculated in the engineering structure of the current building. As a result, more construction works can be done without interrupting existing production lines.
